**USES:** KETOCHLOR® SHAMPOO with Spherulites® is an antiseborrheic shampoo for the management of conditions responsive to ketoconazole or chlorhexidine. The shampoo may be used on dogs, cats and horses.

**ANTI-ADHESIVE** glycotecology\* utilizes a unique combination of monosaccharides and an alkylpolyglucoside that reduces bacterial and yeast adhesion to the *stratum corneum*. This action physically disrupts micro-organism colonization on the skin surface and may delay onset of irritation due to topical bacteria or yeast.

**SPHERULITES:** an exclusive and patented encapsulation system that provides a slow release of ingredients long after product application.

**Chitosanide:** a natural biopolymer that creates a protective film on the skin and haircoat.

**ACTIVE INGREDIENTS:** Chlorhexidine gluconate 2.3% w/w (2% in free form; 0.3% encapsulated).  
Ketoconazole 1% w/w.

**DIRECTIONS FOR USE:** Shake well before use. Wet the hair coat with warm water and apply a sufficient amount of shampoo to create a rich lather. Massage shampoo into wet hair coat, lather freely. Rinse and repeat. Allow to remain on hair for 5 to 10 minutes, then rinse thoroughly with clean water. May be used initially 2 to 3 times a week for four weeks, then reducing to once a week, or as directed by your veterinarian.

**WARNING:** Keep out of reach of children. Wash hands after use.

**CAUTION:** Federal law (USA) restricts this drug to use by or on the order of a licensed veterinarian.
